OFFICIAL RULES

ELIGIBILITY

Only cards received by 5:00 PM, May 31, 2024 will be eligible. Only one mailed entry per person. Northern Kentucky Federal Credit Union is not responsible for cards lost or damaged in the mail. Automatic entry and eligibility for this prize promotion is based upon: Any member that closes on a new or used auto loan, closes on a Second Mortgage or Home Equity Loan, or closes on a Signature Loan during the time period of the sweepstakes will automatically be entered to win. Applying for and closing on loan does not improve your chances of winning. The odds of winning depend on the number of qualified entries received.

FOR AUTOMATIC ENTRIES

If there are multiple parties listed on an account, entry will be based on the first party named on the loan; regardless of whether the transaction qualifying for the sweepstakes is actually conducted by the first part named on the loan.

PRIZE

One (1) individual will be selected in a random drawing from among all eligible entries received during the sweepstakes period to receive a SoloStove Yukon 2.0 Firepit. The odds of winning depend on the number of qualified entries received. The Sweepstakes drawing will be held on or around May 31, 2024. Only entries received before the end of the Sweepstakes period will be eligible. The odds of winning depend on the number of eligible entries received. The winner will be notified at the phone number, address, and/or e-mail address submitted with the entry. If the selected winner fails to contact the Credit Union to claim the prize within fourteen (14) days of the sending or posting of

notification, or if the selected winner cannot be located through reasonable, good-faith efforts by the Credit Union, an alternative winner may be selected from among the remaining eligible entries. If by reason of a printing, computer, production or other error, more than one winning entry is claimed, all persons making purportedly valid claims will be included in a random drawing toward the prize.

In the event this Sweepstakes is compromised or becomes technically corrupted in any way, the Credit Union reserves the right to cancel, terminate or suspend the Sweepstakes and in such event, to select winner for the prize by random drawing from among all valid entries received, up to such time cancellation, termination or suspension. Entrants agree to be bound by these Official Rules.

By submitting an entry form, each entrant grants the Credit Union, and those acting under its authority, permission to use his/her name, likeness and comments for advertising or publicity purposes without payment of additional compensation, unless prohibited by law.

DATA COLLECTION/PRIVACY

The Credit Union will be collecting personal data about participants when they enter the Sweepstakes. Personal data includes: name, address, email address, and phone number(s). The information collected is never sold, given or disclosed to third parties.

INDEMNIFICATION AND LIMITATION OF LIABILITY

GOVERNING LAW
